This agreement may be cancelled at any time upon ten (10) business day's written notice from me/us prior to the next scheduled debit.

I/we have certain recourse rights if any debit does not comply with this agreement. Oakville Hydro reserves the right to cancel this agreement if, for any reason, a payment is not received.
